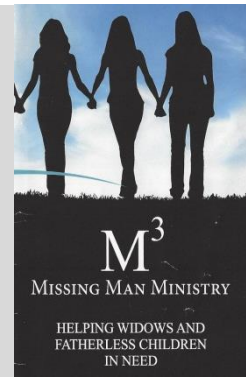


Missing Man Ministry

Missing Man Ministry “Non Profit” started in April of 2011 after a group of men supported a young woman in the community as she nursed her husband through the final stages of cancer and was left a widow with three children and no income. The specific objectives and purposes of MMM are to provide aid and short-term economic assistance primarily to those recently affected by the loss of a husband and father.

Repairs for Homes and Cars, Garden Maintenance, Re-decorating, Financial Advocacy, Home Sale and Moving

Highlights of this Year’s Activity

Holiday Shock
 One woman had a very shocking time at Christmas when her husband passed away suddenly only a few days before Christmas Day. She was in shock and MMM were able to come along side and quickly organize funding and support that allowed for all the necessary bills to be paid over the holiday period as well as some gifts for all the children. Not attempting to replace a father, but at least ensuring that they would be taken care of at such an emotional time of the year.

Financial Advocacy
 There are many financials issues that come up through the year and, in most cases, good results prevail. Not always, and sometimes a significant amount of time goes into review of documentation and research follow up. We are grateful for the hours of work our volunteers put into this activity and that thousands of dollars have been saved or reclaimed.

Flying Parts
 One client, recently widowed owned with her husband a specialty parts business for vintage aircraft. An offer for the specialized inventory of the company was made, but it needed a fast turn-around. The parts needed special packaging, so qualified packers were hired to expertly pack the parts and get them shipped out and sold for in excess of \$10,000. A real help to the cash flow at a critical time.

Mobile Home
 MMM Connected with a couple who had been supporting two widows each with two children. There were some repairs that were needed in the mobile home and various requirements [including new bikes] for the Children, all younger than 14, that MMM was able to help with. As the Covid-19 pandemic hit, unemployment was an issue, and some financial assistance was provided. However, like so many of our Clients these women do all they can to make their own way. MMM is in the process of getting a deck area designed and approved that they will install in the fall if possible. As the new school year starts we will be checking in on the tools needed for “effective” distance learning!

Repaired Trailer Home... a Sold Trailer Home
 One Client was having trouble maintaining the mobile trailer home in Livermore. After sending out a request to the MMM supporters one gentleman took it upon himself to go and inspect what was needed and promptly carried out all the repairs. This included leaking roofing, unsafe access, entry, and some electrical work. Some additional paint and cleaning and the home was dry and safe. MMM’s Client needed to leave Livermore to be with Grandchildren out of state, so she was able to sell the Trailer home to Tri-Valley Seek & Save who were able to donate to two women in need of a place to live.

Bay Area Reach
 MMM work in the Livermore, Danville & Hayward region. The intent was to develop an extended self-directed team in Brentwood, but the effect of the pandemic has delayed this. If anyone is interested in joining or representing MMM in their area, we would love to help, so please let us know.
